Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security. **The bidder is required to scan all written /printed pages of the bid security and upload the same in PDF format to the system in the designated place of the technical bid.**

7. Bids shall be received only "on line" **up to 5.00 PM. Of 22.02.2021**
8. Bids received online shall be **opened at 12.00 NOON on 23.02.2021** at corporate office, Bhubaneswar in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
