For and on behalf of the Odisha State Warehousing Corporation e-tenders under “TWO BID SYSTEM” are invited from interested parties in the e-Procurement Portal, Govt. of Odisha (<http://tendersodisha.gov.in>) for appointment of regular H&T contractors for Handling & Transportation of foodgrain stock of different depositors in the Warehouse at Bhawanipatna-II (Internal & RH Kesinga) for a period of two years and extendable by further three months at the discretion of the Corporation. The tenderer without requisite experience as mentioned in the tender document may participate in the tender as the estimated contract value is less than Rs.5.00 crore subject to providing an undertaking that an additional Performance Guarantee in the form of Bank Guarantee of 10% of the contract value from SBI or its Associate Banks or other Public Sector Banks will be given, if selected. The format of the Bank Guarantee to be provided in such cases is at Appendix-V.

N.B No definite volume of work to be performed during the currency of the contract can be guaranteed by the Odisha State Warehousing Corporation. EMD & S.D. indicated above are calculated on the estimated value of the contract.

The successful tenderer will have to submit the original hard copy of MTF duly signed on each page of MTF alongwith annexures /appendices duly attested on the date and time stipulated by OSWC for verification, failing which the EMD furnished by the Bidder is liable to be forfeited and further that the award of contract through the letter of acceptance will be issued to the successful tenderer only after he fulfills this requirement.

There should normally be no post tender negotiations. If at all negotiations are warranted under exceptional circumstances, then it can be with L-1(Lowest Tenderer) only.

The rates quoted are inclusive of EPF/ESI dues payable to the workers.

The rate quoted should be inclusive of tax, duties, cess etc. as applicable.

The successful tenderer will be abided by the rules and regulations as applicable from time to time by the Govt. of Odisha/ Govt. of India.

1. Attested copy of Registered Deed of Partnership/Memorandum and Articles of Association/ By-laws/ Certificate of Registration etc. as applicable.
2. Power of Attorney of person signing the tender
3. Certificate of experience and details thereof in the proforma at **Appendix-VI**
4. Copy of Certificate of Registration under “The Carriage by Road Act, 2007 and the Carriage by Road Rules, 2011”
5. Duly audited P&L account and Balance Sheet of relevant completed years for which experience certificate has been submitted by the tenderer.
6. Copy of Income Tax Return/ PAN Card
7. Copy of EPF Code Number
8. Tender submission undertaking (**Appendix –VII**)
9. Undertaking regarding uploading true and correct information (**Appendix -VIII**)

Intending tenderers are advised to visit the place of operations for acquainting themselves with the nature of work and prevailing labour system at the concerned Railhead/Warehouses before submitting the tender. Conditional tender and the tenders not accompanied with the EMD and cost of tender shall be summarily rejected.

The bidders are required to upload the technical bid and price bid separately.

The Technical Bid will be opened online in the Office of the OSWC at the scheduled date and time indicated in the NIT. The Tenderer will be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.

The date and time of opening of Price Bids of the tenderers qualified in the technical bid shall be intimated by the OSWC. The Tenderers qualified in the technical bid will be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.

If the date fixed for opening of tenders is subsequently declared a holiday, the tenders will be opened on the next working day following the holiday but there will be no change in the time for opening as indicated above.
