The Tender Paper cost and Earnest Money Deposit / Bid security of the amount specified for the work in Col. 04 above, the bidder shall make electronic payment using his / her Internet banking enabled account with designated Bank or their aggregator Bank such as SBI / ICICI / HDFC or the bidder having account in other bank can make payment using NEFT / RTGS facilities of designated banks. Bidder is desiring to hire machineries or equipment from outside the State or owned but deployed outside the state is required to furnish 2 % of the amount put to tender as Bid security. The bidder is required to scan all written /printed pages of the bid security and upload the same in PDF format to the system in the designated place of the technical bid.
- 5. The Bid documents will be available in the website: and <a href="www.oswc.in.">www.oswc.in.</a> from 11.00 AM of 12.03.2024 to 26.03.2024 5.00 PM for online bidding.
- 6. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
- 7. Bids shall be received only "on-line" up to 5.00 PM. Of 26.03.2024
- 8. Bids received online shall be **opened at 3.00 PM on 27.03.2024** at corporate office, Bhubaneswar in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 9. The cost of bid documents as mentioned in Column 05, the bidder shall make electronic payment using his / her Internet banking enabled account with designated Bank or their aggregator Banks such as SBI / ICICI / HDFC or the bidder having account in other Bank can make payment using NEFT / RTGS facilities of designated Banks.
- 10. The Engineer contractor willing to avail the Exemption of EMD will submit scan copy of the affidavit to avail the exemption along with bid document and original affidavit will be submitted before opening of technical Bid. Affidavit should contain how many times such facilities have been availed by him prior to this during the current financial year. Otherwise, they will not be entitled to avail such facilities.
- 11. The additional performance security deposit: The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted in the percentage of amount put to tender before the signing of agreement of the contract as per the memorandum no 4559 dt. 05.04.21 works dept. of Odisha modified to APS will be followed as detail below.
