## PART-A

### **Terms & Conditions for hiring of godown space of 2950 sq. ft. at OSWC, Bhubaneswar (Satyanagar)**

1. An Agreement shall be executed between the OSWC (herein after called as 1<sup>st</sup> Party). & the successful bidder (herein after called as 2<sup>nd</sup> Party) for an initial period of one year which may be extended on mutual consent of both parties.
2. The godown space of 2950sq.ft. (i.e.492 MT) shall be utilized by the 2<sup>nd</sup> party at SWC Bhubaneswar for which the 2<sup>nd</sup> party will pay storage charges to OSWC as per the rate quoted (excluding GST) by the 2<sup>nd</sup> party. Any other tax levied by the Central/State Govt. as applicable from time to time shall be paid by the 2<sup>nd</sup> Party in addition to monthly storage charge & GST as applicable. The rate of storage charge will be enhanced proportionality on yearly basis (i.e. on 1<sup>st</sup> of April of every year valid up to 31<sup>st</sup> March of the succeeding year) considering the hike in storage charge of OSWC for other commodities which will be paid by the 2<sup>nd</sup> party.
3. The 2<sup>nd</sup> party has to deposit a security amount (which is 3 times of the monthly Storage charges-excluding GST) with Odisha State Warehousing Corporation which is refundable on vacation of godown space of the warehouse. No interest will be paid on security deposit.
4. The 2<sup>nd</sup> Party shall make their own arrangement for comprehensive insurance of the stock to be stored. The 1<sup>st</sup> Party shall not be responsible for any loss/damage to the stored materials.
5. The 2<sup>nd</sup> Party shall keep the stock under its own custody with watch & ward service and handling of stock shall be done on own arrangement.
6. The 2<sup>nd</sup> Party shall pay the monthly storage charges within the first week of the succeeding month upon receipt of the bill from the Superintendent, OSWC Bhubaneswar. In case of failure to make payment within seven (7) working days of

receiving the bill, a penalty interest of 3% per month on the outstanding storage charge shall be levied by the 1<sup>st</sup> Party.

7. If the 2<sup>nd</sup> Party fails to deposit the storage charges for a period exceeding three (3) months, the First Party (OSWC) reserves the right to seize and/or auction the stored stock after providing prior notice. OSWC shall retain a lien on the stock deposited by the 2<sup>nd</sup> Party against the unpaid storage charges.
8. The 2<sup>nd</sup> Party is strictly prohibited from subletting or assigning the allotted space to any third party. The 2<sup>nd</sup> Party shall also refrain from storing or engaging in any activity involving goods or articles prohibited under applicable laws. The 2<sup>nd</sup> Party shall not store any commodities other than agreed upon without obtaining prior written approval from the 1<sup>st</sup> Party (OSWC).
9. The 2<sup>nd</sup> Party shall not make any structural alterations or additions to the godown without the prior written consent of the 1<sup>st</sup> Party. The 2<sup>nd</sup> Party shall maintain the godown in good condition. Before vacating the space, the 2<sup>nd</sup> Party shall obtain a certificate from the Godown In-Charge confirming the storage-worthiness and condition of the godown.
10. The 2<sup>nd</sup> Party should not make any permanent structure on the premises without prior approval of the 1<sup>st</sup> Party.
11. The 2<sup>nd</sup> Party shall ensure the installation and maintenance of CCTV surveillance systems within the godown premises.
12. The 2<sup>nd</sup> Party shall ensure for installation of fire extinguishers and other safety measures in the godown and maintain the same at regular interval.
13. The 2<sup>nd</sup> Party shall ensure the installation of an external electrical cut-off switch for emergency purposes.
14. The 1<sup>st</sup> Party (OSWC) reserves the right to depute authorized officials to inspect the stock stored by the 2<sup>nd</sup> Party within the allotted space, as and when required.

15. For any dispute, the matter will be placed before the Managing Director, OSWC for amicable settlement. The decision of the MD, OSWC on the matter shall be final and binding.
16. Any dispute arising between the parties in relation to this arrangement shall be subject to the exclusive jurisdiction of the courts located at Bhubaneswar. No other court shall have jurisdiction over any matter pertaining to this tender or contract.
17. In case of de-hiring of reservation of space by the 2<sup>nd</sup> party, one month notice shall be given in advance by the 2<sup>nd</sup> party after completion of minimum one year reservation period.
18. The agreement can be terminated by the 1<sup>st</sup> Party by giving one month advance notice for any act of violation of terms & conditions within the agreement period by the 2<sup>nd</sup> Party and the security amount shall be forfeited.
19. In the event of a tie between the quoted prices of the bidders, the selection of the successful bidder shall be determined through a lottery system.
