The concerned candidates are once again hereby asked to appear before the Secretary, Odisha State Warehousing Corporation, Plot No-2, Cuttack Road, Bhubaneswar 751006 on **15.09.2022 at 11. A.M** positively failing which their candidature for the post concerned shall be forfeited and in this context their claim in future shall not be taken into consideration.

They are required to bring the certificate/documents as listed below from (i) to (xv) in original along with self attested Xerox copies of the same and the copy of the application form during certificate verification. The original documents to be submitted during certificate verification must tally with the documents uploaded by the candidate. The candidate claiming reservation/age relaxation under ST/SC/SEBC categories must submit the valid caste certificate issued by the Competent Authority to get reservation/age relaxation in the respective category.

- i. Conduct/Character certificate fresh from a Gazetted Officer.
- ii. Declaration regarding any criminal antecedents (**Annexure-II**).
- iii. Copy of online application form.
- iv. Two recent passport size photograph (unsigned & unattested) which has been uploaded with the online application form.
- v. HSC or equivalent pass certificate in support of declaration of age issued by the concerned Board/Councils and Mark sheet.
- vi. Intermediate/+2 Higher Secondary examination equivalent pass Certificate and Mark sheet issued by the concerned Board/Council.
- vii. Degree/Graduation pass certificates and mark sheet issued by the recognized University.

- viii. Master Degree/Post Graduation pass certificate and mark sheet issued by the recognized University.
- ix. PGDCA/BCA certificate with minimum one year duration of course.
- x. Caste certificate by birth in support of claim as SC/ST/SEBC wherever applicable.
- xi. Resident certificate issued by Competent Authority.
- xii. Candidates have to submit certificate of passing HSC Examination with odia as a compulsory subject, or in lieu thereof a certificate of passing a language test in odia in final examination of class-vii issued by Principal/Head Master or any Educational Institution duly recognized by Govt. of Odisha/Central Govt. or other Competent Authority.
- xiii. Discharge certificate, identity card and PPO issued by the Commanding officer/Appropriate Authority indicating therein the date of entry, date of discharge and period of service rendered in defence forces.
- xiv. Disability certificate indicating percentage of disability 40% or more issued recently by concerned Medical Board wherever applicable.
- xv. Candidates claiming reservation under sports person category should be a person of State or National level and must submit the recent/within last 5 years Identity Card issued by the Director, Sports & youth Service, Department, Govt. of Odisha.

NB:-

- i. Candidates claiming to be belonging to ST,SC,SEBC category of Odisha by birth are required to submit copy of the relevant Caste Certificate issued by the Competent Authority in the prescribed form. Candidates of SEBC category must submit copy of SEBC certificate issued by the Competent Authority within last three years from the date of advertisement.
- ii. Women candidates belonging to SC/ST/SEBC are required to submit caste certificate by birth showing "daughter of _____" Caste certificate by virtue of marriage (i.e. showing "wife of _____" is not accepted.
- iii. The candidates who will fail to appear in the certificate verification on the scheduled date, their names will not be taken into consideration while preparing the final merit list.
